NOTICE TO PARENT/GUARDIAN

It is a condition to the Child's participation in the Activity that you, the undersigned Parent/Guardian of the Child, must carefully read and understand this document and sign it to acknowledge that you have read and understand it and that you understand that the Child's participation in the activity will expose the Child to risks of harm and that you accept full responsibility for exposing the Child to such risks.

PARENT/GUARDIAN RESPONSIBILITY FOR CHILD

I, the undersigned Parent/Guardian of the Child, understand and accept that, with respect to the Child's participation in the Activity, it is my responsibility (1) to ensure that I consider and understand the risks, dangers, hazards and consequences of injury inherent in the Activity, (2) to determine, taking into consideration those risks and the Child's behavioural characteristics, physical health and abilities, whether the Child should be allowed to participate in the Activity, (3) to ensure that the Child is appropriately covered by medical insurance for any harm occurring in the Activity, and (4) to provide emergency medical information regarding the Child as required in this document.

AWARE OF RISKS

I AM AWARE OF, AND NOW FREELY ACCEPT AND ASSUME RESPONSIBILITY FOR, ALL RISKS TO THE CHILD IN CONNECTION WITH THEIR PARTICIPATION IN THE ACTIVITY, INCLUDING AS FOLLOWS:

- (1) the Child's participation in the Activity, even if the Child possesses behavioural characteristics, physical health and abilities appropriate for the Activity, poses risks of harm to the Child;
- (2) the nature of the Activity is such that the Community Centre cannot identify all of the risks associated with the Activity and cannot guarantee that Community Centre staff participating in the Activity will not make errors in administering or supervising the Activity or that other children participating in the activities will not cause injuries or harm to the Child.
- (3) the nature of the Activity is such that the Child will interact with other people who are considered to be in good health, continuous physical distance between the Child and other people cannot be guaranteed, and, by participating in the Activity, the Child risks being infected by a pathogen, including but not limited to SARS-COV-2, which causes the disease COVID-19.

I, THE UNDERSIGNED PARENT/GUARDIAN, AM THE PARENT AND/OR LEGAL GUARDIAN OF THE CHILD AND I HEREBY CONSENT TO THEIR PARTICIPATION IN THE ACTIVITY, AND, IN RETURN FOR THE COMMUNITY CENTRE ALLOWING THE CHILD TO PARTICIPATE IN THE ACTIVITY:

- 1) I NOW WAIVE ALL LEGAL RIGHTS TO SUE AND ANY AND ALL CLAIMS** which I and/or my successors and assigns may have against the Community Centre in connection with any loss, injury, damage or expense that I may suffer, incur or experience in connection with the Child's participation in the Activity; and
- 2) I HEREBY RELEASE** the Community Centre from any and all liability for any complaints, demands, claims, actions, suits, judgements and orders for, or with respect to, any and all losses, injuries, damage or expenses I may suffer, incur, or experience in connection with the Child's participation in the Activity; and
- 3) I AGREE TO INDEMNIFY** the Community Centre for, and hold it harmless from, any and all losses, injuries, damages and expenses of any kind that the Community Centre may suffer, incur or experience and for any and all complaints, demands, claims, actions, suits, judgments and orders against it with respect to any and all losses, injuries, damages or expenses of any kind anyone, including the child, may suffer, incur or experience to the extent they or any of them arise from or are in any way connected to my conduct or the Child's conduct in or participation in the Activity.

JUNIOR INFORMED CONSENT, DISCLOSURE AND ACKNOWLEDGEMENT OF RISKS

TO: **False Creek Canoe Society, doing business as False Creek Racing Canoe Club ("FCRCC"), and its directors, officers, members, agents, officials, organizers, volunteers and other representatives (all collectively referred to as the "Club");**

AND TO: **the False Creek Community Centre ("FCCC"), Vancouver Board of Parks and Recreation, the City of Vancouver and their respective directors, officers, members, agents, officials, organizers, volunteers and other representatives (all collectively, the "City").**

IN CONSIDERATION of the Club granting to _____ (the "Junior Participant") **being permitted to use the Club's and FCCC equipment and facilities and to participate in the paddling, training, coaching, racing, operational, maintenance and other activities of the Club (collectively, the "Activities"),** the undersigned parent or legal guardian of the Junior Participant agrees as follows:

1. **COMPLIANCE WITH RULES.** The Junior Participant is required to abide by the rules and regulations established by the Club from time to time applicable to the Activities, including, without limitation, the wearing of a personal floatation device (PFD) if required. During the Junior **Participant's** participation in the Activities, the Junior Participant is expected to act responsibly with a view to preserving my own safety and the safety of other participants.
2. **RISKS, DANGERS AND HAZARDS.** I acknowledge that the Activities involve risks, dangers and hazards inherent **in canoeing, kayaking and associated outdoor water sports (collectively, the "Inherent Risks"), and further** acknowledge that in addition to the Inherent Risks, the Activities involve certain additional risks, dangers and hazards, some of which may include (but are not limited to): physical exertion for which the Junior Participant may not be prepared; weather extremes, including sudden and unexpected changes; dangerous water conditions, including cold water and movement, waves, currents, rapids and white water; immersion in cold water; hypothermia; underwater entrapment; collision with natural and man-made objects, including rocks, docks and other boats; slippery docks; equipment malfunction or failure; and delay or inability for rescue or medical treatment in a timely manner **(collectively, the "Additional Risks"). I have informed the** Junior Participant of the Inherent Risks and Additional Risks associated with the Activities.
3. **INFORMED CONSENT; ACKNOWLEDGEMENT OF RISKS.** I am the parent or legal guardian of the Junior Participant and I hereby freely consent to the Junior **Participant's** participation in the Activities. I acknowledge and am fully aware that in participating in the Activities, the Junior Participant is being exposed to risks of personal injury, death or property damage or loss, which may result from many causes, including the Inherent Risks, the Additional Risks, active or passive negligence, imprudence, lack of skill, error of judgment, breach of contract or breach of statutory duty of care on the part of the Club or City. I acknowledge that the Junior Participant is voluntarily participating in the Activities for his or her benefit and enjoyment and the excitement associated with the Activities, despite being informed of the Inherent Risks and Additional Risks associated therewith.
4. **DAMAGE TO EQUIPMENT.** I agree that if the Junior Participant damages or loses any equipment of the Club or the City or damages any facility of the Club or the City, I agree that I may be held responsible for some or all of the insurance deductible payable. If insurance does not cover the damage or loss, then I agree that I may be held responsible for the cost of repairing the damage or replacing the lost equipment.
5. **NO WARRANTIES.** I acknowledge that in signing this Agreement, I am not relying on any oral, written or visual representations or statements of any kind made by the Club or the City.
6. **GENERAL PROVISIONS.** This Agreement shall be binding on my heirs, next-of-kin, executors, administrators, assigns and representatives in the event of my death or incapacity. If any provision of this Agreement is held invalid or unenforceable, it will be severed from this Agreement and will not affect the validity or enforceability of the remaining provisions of this Agreement. This Agreement sets out the entire agreement between the parties regarding the subject matter hereof and may not be amended. This Agreement shall be governed by the laws of the Province of BC.
